

## Bacti-Klear Pellets Aquatic Microbial Blend

**DIRECTIONS FOR USE:**

For use in lakes, ponds, water hazards and irrigation tanks.

Apply between Spring and Autumn, at any time of the day when water temperature exceeds 50°F.

Works effectively in a broad pH range between 5.5 and 8.5.

- Wear proper safety equipment including rubber gloves and eye protection when handling or applying product.
- Determine the surface acres of the treatment area: Length (ft.) x Width (ft.) / 43,560 = Surface Acres
- Determine the amount of product required, using the chart below.

| <b>Start-up Applications<br/>(Pounds per Surface Acre)</b> | <b>Maintenance Application<br/>(Pounds per Surface Acre)</b> |

**Start-Up Applications:** Apply specified dose every 30 days until desired level of muck reduction is achieved.

**Maintenance Applications:** Apply specified dose every 30 to 60 days to maintain desired appearance.

Spread pellets evenly using a scoop, handheld fertilizer spreader, or mechanical-type spreader.

**STORAGE & DISPOSAL:** Store in cool place in closed container out of direct sunlight. Do not reuse empty container. Rinse empty container thoroughly with water, then offer for recycling, or dispose in accordance with state and local regulations.
